Question No.	Question	Response
1	Do you use the Business Names Register or use services that provide information from that Register? If so, what is the information primarily used for?	Yes. The search system is used to carry out searches to ascertain the owner of certain business names in Ireland.
2	What are your views on the requirement for all newspaper proprietors to register their business name under the Act? Should this requirement be extended to other types of media or repealed? Please provide reasons for your views.	We are of the view that it is in the public interest to be able to identify the proprietors of all types of media. If the requirement is there for Newspapers and retained we would expect this should extend to all media or else be repealed, we do not see a reason to extend to only one media outlet.
ω	What are your views on the disclosure of business name requirements? Should they be expanded, reduced or eliminated? Please provide reasons for your views.	We believe that disclosure is an important aspect of good governance where a business is trading under a business name so that people can ascertain who they are dealing with. For example the majority of legal and accounting firms trade as partnerships but the registration of a business name allows for visibility on this and the relevant partners.
4	What are your views on extending the powers of the Registrar to amend or delete a name from the Business Names Register in certain circumstances? If so, please provide examples.	We see no issue with and would welcome the Registrar being allowed to delete or remove business names under certain circumstance once the owner is given advance notice of the deletion or removal and is permitted the right of challenge. We would suggest that if a limited partnership or company is dissolved and ceased that any associated business name would also be automatically cancelled/ceased.
v	What are your views on the Registrar automatically updating the Business Names Register when the Companies Register and the Limited Partnership list is updated?	We would like further clarity on this but in board terms do not see it as an issue. We would suggest that if a limited partnership or company is dissolved and ceased that any associated business name would also be automatically cancelled/ceased.
