Economic Migration Policy

Ireland operates a managed employment permits system maximising the benefits of economic migration and minimising the risk of disrupting Ireland's labour market. The system is intended to act as a conduit for key skills which are required to develop enterprise in the State for the benefit of our economy, while simultaneously protecting the balance of the labour market.

The system is, by design, vacancy led and driven by the changing needs of the labour market, expanding and contracting in tandem with its inherent fluctuations. In order to ensure that the employment permits schemes are responsive to changes in economic circumstances and labour market conditions, the system is managed through the operation of the Critical Skills Occupations List and the Ineligible Occupations List for the purpose of granting an employment permit. As demand grows or recedes, the level of economic migration adjusts accordingly.

It is vital that the employment permits schemes are responsive to changes in economic circumstances and labour market conditions. Therefore, in order to maintain the relevance of these lists of occupations and to ensure the employment permits system is aligned with current labour market conditions and intelligence, it is necessary to review the highly skilled and ineligible lists on a regular basis, in accordance with the changing needs of the economy and the labour market.

The lists are subject to twice-yearly review which examines labour market conditions at occupation level and adjusts access to the Irish labour market for non-EEA nationals on the basis of available evidence. The process involves indepth examination of the research and labour market intelligence undertaken by the Skills and Labour Market Research Unit (Solas), the Expert Group of Future Skills Needs, and the National Skills Council, review of relevant Reports, education outputs and initiatives, sectoral upskilling and training initiatives and any known contextual factors (e.g., planned expansions in sectors, if known). The observations and input of relevant Government Departments are also incorporated in addition to the public consultation process. Submissions to the review process are also considered by the Economic Migration Policy Interdepartmental Group chaired by the Department of Business, Enterprise and Innovation with membership drawn from senior officials of key Government Departments and Solas.

The Quarter 4 2018 review commenced at the end of October 2018 and employers, industry representatives, Government Departments, Agencies, social partners and NGOs were invited to provide observations as part of the public consultation phase which closed on 2 November 2018. The Economic Migration Policy Unit of the Department of Business, Enterprise and Innovation received 48 submissions to the review, of which 11 sectors in the economy were covered as follows:

Proposals for change of status of occupations was submitted to Minister Humphreys for consideration and approval. Minister Humphreys approved changes to the occupations lists and announced amendment to Regulations on 22nd April 2019 for the following occupations:

• add to the critical skills list:

- o Civil engineers
- Quantity surveyors
- o Construction project managers
- o Mechanical and electrical engineers with BIM capabilities
- o High Performance Directors and Coaches for high-level sports organisations

• remove from the ineligible list:

- Sheet metal workers
- Welding trades
- o Pipefitters
- Air-Conditioning & Refrigeration Engineers
- o Shuttering Carpenters
- o Glaziers, window fabricators & fitters
- o Scaffolders, stagers & riggers
- o Crane drivers
- Career guidance teachers (secondary schools)
- remove from the ineligible list by quota:
 - Transport and Distribution Clerks and Assistants (Freight Forwarders; Cargo & Freight Agents; Brokerage Clerks) subject to a quota of 300,
 - Plasterers subject to a quota of 250
 - o Bricklayers subject to a quota of 250

Other amendments included in these Regulations apply to the criteria for employment permits for chefs which will allow employers to replace permit holder employees who leave their employment prior to the expiry of a permit; plus to recognise the total years' experience gained by an applicant in any grade of chef rather than limiting to their experience in one specific chef grade.

The Regulations have also been changed to update references to Revenue Commissioners documentation that may be required when processing an application such as P60, P35, P30 etc. Since January this year, Revenue introduced a new PAYE Modernisation initiative which means that employers are required to report employees' pay and deductions to Revenue in real time. The new method eliminates these traditional revenue documents, replaced by more accurate, live information relating to payroll and statutory deductions.
